



SEXUAL MISCONDUCT INFORMATION AND RESOURCES

Manhattanville College is a community of inquiry committed to promoting the free exchange of ideas and to providing a safe and nondiscriminatory environment for students and employees that recognizes the intrinsic worth and dignity of all individuals.

The College will not tolerate discrimination on the basis of sex or gender by any College employee, student, or third party. Any individual who has been the victim of an act of sexual violence or harassment is urged to make an official report, pursuant to which the College will initiate a prompt, thorough, and impartial investigation. This investigative process is designed to provide a fair and reliable determination as to whether the College's Non-Discrimination and Harassment and Sexual Misconduct policies have been violated. If so, the College will implement a prompt and effective remedy to end the discrimination, prevent its recurrence and address its effects.

Reporting:

Upon receipt of notice of any allegation of sexual misconduct, the College shall ensure that Complainants are advised of their right to:

- Notify proper law enforcement authorities, including on-campus and local police
- Be assisted by campus authorities in notifying law enforcement authorities if the Complainant so chooses
- Decline to notify such authorities. 20 U.S.C. §1092 (f)(8)(B)(iii)(III)(aa)-(cc).

Bystander Intervention:

We need to help care for each other by intervening or interrupting harmful behavior or speech that is witnessed by:

- Confronting people who seclude, hit on, try to make out with, or have sex with people who are incapacitated
- Speaking up when someone discusses plans to take sexual advantage of another person
- Calling police when a person is yelling at another and it is not safe for you to interrupt
- Interjecting yourself into a conversation where another person seems unsafe
- Refusing to leave the area (or call police) if a person is trying to get you to leave so they can take advantage of another
- Speaking up when people use racist, sexist, homophobic, or other harmful language
- Offering to drive an incapacitated friend home from a party
- Ensuring friends who are incapacitated do not leave the party or go to secluded places with others

Training and Prevention:

In an effort to further advance our students beyond the classroom, Manhattanville College has partnered with [EverFi](#), whose mission is to help students address critical life skills such as alcohol abuse prevention and sexual misconduct prevention in high schools and higher education institutions across the country.

Manhattanville College requires all first year students to complete AlcoholEdu and the HAVEN Program. These online courses help students develop the critical skills to make more thoughtful and educated choices outside the classroom. Throughout the academic year, additional programming is offered by the Dean of Students office as well as by campus clubs and organizations.
